#### Call to order

In the absence of Russell, Walker called the meeting to order at 11:02 a.m.

## Review and Recommendation to approve Finance Committee Meeting Minutes August 8, 2022

Walker called for approval of the August 8, 2022, minutes.

# Motion made to approve the August 8, 2022, Finance Committee meeting minutes by Fiorello, seconded by Gennaria and unanimously approved.

Walker asked Gratza to present the following:

### August 2022 Cash Flow Update (KEB)

Gratza presented an update on the August 2022 cash flow (included in the Board packets) as follows: (1) actual through August and projections September through December; (2) actual cash flow and ending month cash balances; (3) total projection through December for Hotel/Motel tax revenue and payroll expenses; (4) grants variance; and (5) projected ending cash balance for the year compared to prepandemic levels.

Cooksey shared - in terms of forecasts – the monthly revenue comparisons 2019-2022 and noted importance to maintain commitments to grantees based on revenue cycles. Cooksey then explained forecast distinctions for Explore St. Louis.

Discussion was held regarding the following: (1) comparison differences for first half of fiscal year and importance of rollover funds for grants and operations in 2023; (2) reasons for variances between Explore STL 2021 and 2022 forecasts; (3) anticipated trends based on Explore STL forecast; (4) effects of political environment; and (5) this topic as significant conversation during September Retreat.

## PPP Loan #2 (KEB)

RAC

Gratza reminded that RAC filed for forgiveness for Paycheck Protection Program (PPP) Loan #2; PNC required additional information; still waiting on response.

## **Employee Retention Credit (KEB)**

Gratza reminded that RAC filed for the Employee Retention Credit (ERC) three different quarters; Q1 was denied by the IRS, Q2 was paid by the IRS, and have not heard anything regarding Q3.

## **Adjournment**

There being no further business, Walker called for motion to adjourn. Motion made by Gennaria, seconded by Fiorello, and unanimously approved to adjourn the September 6th Finance Committee at 11:28 a.m.
